ENHANCING INFECTION PREVENTION AND CONTROL TO RESPOND TO COVID-19 IN BRAZIL (PREVCOVID-BR)

PREVCOVID-BR has a partnership with the Fundação de Vigilância em Saúde do Amazonas - FVS/AM (*Health Surveillance Foundation of Amazonas*) to implement the project in Manaus.

The local coordination team is composed by the nurse Tatyana Costa Amorim Ramos, president of the Comissão Estadual de Prevenção e Controle de Infecção em Serviços de Saúde - CECISS (*State Commission for Prevention and Control of Infection in Health Services* of FVS/AM, and the project's administrative support fellows, Dinaury Araújo de Souza Filho and Timóteo Tadashi Watanabe.



In Manaus, five hospitals are participating in the project. For each hospital, two fellows hired by PREVCOVID-BR were assigned: one fellow for administrative activities (ADMIN) and another fellow focused on

technical activities of infection prevention and control (IPC).

The fellows began data collection to identify the response capacity of hospitals to the COVID-19. The results of this evaluation will provide subsidies to implement improvements for the institution, within the scope of the project, always in partnership with the Hospital Infection Control Commission (HICC). The development of the improvement plan will be the next step for the participating institutions.

DIALOGUES OF PRACTICE PREVCOVID-BR Webinar

Biweekly, PREVCOVID-BR has developed the "Dialogues of Practice" Series, in webinar format, being an activity open to all health professionals from participating hospitals. It is important to register on the ECHO platform, which allows access to the webinar and sending questions and suggestions. This also allows the receipt of the certificate of participation in the event.

This last edition addressed the topics "Practical guidelines on the use of masks in health services" and "Management of visitors in health services". **Fernanda Lessa**, from the International Infection Control Program (IICP) team at CDC/DHQP, presented a series of guidelines for the proper use of different mask models in health services.
